3) Northern Territory history grants

The Northern Territory Archives Service has announced that applications for the 2009 Northern Territory History Grants have opened.

Northern Territory History Grants were established by the Northern Territory Government to commemorate the attainment of self-government on 1 July 1978.

The Northern Territory Government is providing \$50 000 for the 2009 grant program, which aims to encourage and support original research about the Territory's history.

Since 1995 more than \$500 000 has been provided to historical research for radio programs, journal articles, published, unpublished and self published works, oral history interviewing, website production and research for producing videos and films. The Northern Territory has a fascinating and relatively unexplored history – the pattern of settlement was vastly different to the rest of Australia – European settlement occurred in the late 19th century and Aboriginal history extends for thousands of years beyond that. The NT History Grants offer an opportunity to help uncover more of its hidden treasures and secrets. Individuals, societies or community groups from across Australia can apply for single grants ranging from \$500 to \$7000.

Criteria for assessment includes:

- a demonstrated uniqueness of the project,
- provision of achievable project plan,
- identification of funding requested based on a realistic budget; and
- a proposal of how the result of the research will be disseminated.

In 2008 seven recipients from the Northern Territory and nine recipients from interstate shared a \$50 000 grant from the Northern Territory Government towards their research on the Territory.
